The Clerk had been looking at the costs of replacing the website and had been quoted anything from £800 to £1200 from national companies. A local business, LJdigitalmedia was contacted and offered to carry out the work to create a new site for £485.00, with £85 annual hosting fee. Members were disappointed Parishcouncil.net had failed to respond to any contact and failed to deliver a working website. Following a discussion it was proposed by Cllr Townsend and seconded by Cllr Spraggon to appoint LJdigitalmedia to create a new council website. **RESOLVED:** The Clerk will action
