22.111 To Consider Cricketers' Nets Location & Utilities Invoice Payment

Those present were informed that following the Parish Council's solicitor's advice it was relayed that support for permanent nets on the cricket ground cannot be given as it breaches the Charity status rules; the area must remain open to all for recreational use without restriction. The solicitor also advised that the cricket ground area is not operating in line with the Charity status by being used solely for use by cricketers and not available to general recreational use. Options suggested were that the Parish Council dispose of the recreation ground and Cricketers become Trustees for the cricket ground or alternatively the cricketers rent the ground for the going rate. It was confirmed that a reply from the Coalmining Charity, CISWO is awaited.

It was proposed that the Trustees update themselves on the Charity Status conditions and the Chair agreed to circulate the relevant document to all.
