- It was reported that a swing at the Welfare Ground is broken and needs to be removed. Clerk to make enquiries about suitable companies to supply a replacement.

It was also resolved that the previous tenant should be held to account and another written request for him to clear all rubbish he left at the earliest convenience. Clerk to write.
- Due to the resignation of Cllr Sewell, the Parish Council were asked for a replacement to represent the Parish Council Lands Village Hall Association. There were no volunteers and it was suggested that a poster be produced to advertise the two Lands vacancies.
- It was advised that there is a meeting next week for the Emergency Plan groups and a funding request will be submitted to support the plan.

 pruned in the Autumn to make the area more presentable. It was highlighted
 that the removal of all shrubs could encourage unwanted vehicular access.
