## 23.53 TO CONFIRM MINUTES OF PREVIOUS MEETING

## 23.54 TO CONSIDER COUNCILLORS' REPORTS

- It was advised that Ramshaw have identified a suitable defibrillator and request that the Parish Council purchase the device and DCC reimburse the payment when funding is processed as agreed at Cllr Cosslett's request. The maintenance and location of the defibrillator will be provided by Ramshaw residents. The Parish Council support this initiative.
- It was reported that there is new road signage from the Cockfield approach has been sited by DCC to encourage traffic speed reduction.
- The Parish Council was asked for support with obtaining flashing speed matrix; the Parish Council would welcome any assistance with reducing speeding traffic through Evenwood.
- The current Burnlea Farm planning application was considered and the Parish Council support DCC councillors in objecting to the proposals.

- It was advised that DCC led initiative for an Emergency Plan ran a practice scenario at Lands and volunteers will be asked to participate in a table top training exercise to test scenarios in Evenwood. It was advised that funding will become available and needs to be applied for in due course to support this initiative.
- It was reported that a resident has again asked the Parish Council to consider her removing trees and allowing some floral planting. The resident has been advised that nothing can be done until after nesting season at the end of August. It was resolved that the Clerk will respond to her by letter.
- It was reported that volunteers have made various improvements to the groundworks in the cemetery and their efforts were commended.
- It was advised that a letter has been received from the Randolph Institute to request permission to gather on the village green to commemorate their building being open for 125 years. The event on 13<sup>th</sup> July 2023 is supported by the Parish Council.
- It was advised that a new Delaware allotment holder is keeping bees and another allotment holder has raised concerns. Due to the increase from 1 hive to 4 hives the allotments subgroup will investigate concerns.
