Cllr Prince referred to the recorded cleared invoice for Smith Roddam £947.00 on the report. The Clerk advised her the approved payment from May's meeting was for legal fees, ring fenced from the previous year for the lease on the Randolph Community Centre. This was also clarified to Cllr Prince at the May meeting.

RESOLVED: The July/August Financial Report was proposed as a true record by Cllr Spraggon and seconded by Cllr Lyons

Cllr Nicholson advised members that due to the grass not being cut in Lands by the volunteer the council financially supported, the council have arranged a contractor to carry out the work this season. The 2019 season may see this area being added to the current contract.
